  - ✦ Candidates who have not applied for certification by 1 October 2022, who have attended accredited courses before 1 October 2017, will have to redo the qualification and cannot be certified.
  - ✦ SAESI has a no refund policy. No fees payable will be refunded. Candidates who do not accept the outcome of their application can follow the appeals procedure. All information is available upfront regarding the requirements for certification and omission of submission or failure to comply does not warrant a refund.
  - ✦ SAESI will accept applications for the above stated period by email, courier delivery or hand delivery.
  - ✦ NO IMMEDIATE ISSUING OF CERTIFICATES WILL TAKE PLACE FOR HAND DELIVERED APPLICATIONS, irrespective of whether all requirements are met.
